

## ACCEPTANCE LETTER OR DISCLAIMER

Dear Customer:

We are pleased to agree to your request to access and use the System as defined below. Your access and use of the System are subject to the terms of this **Disclaimer terms**, SG Company and Customer hereby agree to the following:

1. **SG Company.** For purposes of this Agreement, "SG Company" shall mean the following company: Societe Generale International Limited

2. **Definitions:**

"System" shall mean, whether hosted by SG, or by an ISV for and on behalf of SG or by an organized, enabling users to enter, accept and order placement and execution.

"ISV" shall mean the Independent Software Vendor providing communications tools requested (media communication tools: WhatsApp and WeChat).

3. **Use of the System:** We are authorizing your use of Systems (media communication tools: WhatsApp and WeChat) to access and use the System as specified in the following terms. You agree that your access and use of any additional Front-End or API shall be subject to a prior validation.

4. **Access, Use, Restriction.** You are granted a non-exclusive, non-transferable, and revocable right to access and use the System to directly enter, accept and order placement and execution. You will not use the System to send messages which are defamatory, fraudulent, contain personal data in contravention of any data protection regulation or legislation, or to facilitate any criminal transaction or act, contravene any law or any regulation, or do or omit to do any act or thing which might give rise to a third party claim against us.

### **5. Responsibility for the Choice of System; Acknowledgment of Risks**

a) You accept responsibility for your selection and use of the System and are solely responsible for providing and maintaining the computer(s), modem and the telephone line or Internet connectivity (as may be applicable) to connect to the System. You further acknowledge that SG shall have no responsibility whatsoever for the system and, if applicable, other application software you choose in relation to your Connection to the System (whether it is your proprietary software or any vendor application).

(b) You acknowledge and agree that trading through the System, which is not a proprietary system of SG, will expose you to the risks associated with software and hardware systems or component failures and unavailability. The results of such failures may be that you are unable to enter or cancel an order, an order is not executed, or is executed incorrectly. Same market conditions used for Symphony traditional services will be applied.

(c) The System may have links to certain Internet sites sponsored and maintained by third parties. We make no representations or warranties concerning the content of such sites and the fact that access to such sites is provided does not constitute our endorsement

6. **Confidentiality.** The Front-End and/or System include non-public and proprietary information and/or property that are of a confidential nature. You shall not disclose such confidential information or property

to any third party or use the System for any purposes outside the scope of these Terms. You shall treat the System with the same level of care with which you treat your own confidential materials and, in no event with less than a reasonable standard of care.

7. **System Unavailability.** You acknowledge that access to the System may be limited or unavailable from time-to-time due, for instance, to technical difficulties and as a result we reserve together with the ISV the right to discontinue providing or to amend the System at any time. We may do this because, among other reasons, you breach these Terms or any other agreements, or we deem it necessary in response to an action(s) by an exchange or regulatory body.

8. **Duties of the User; Compliance with Applicable Regulation.**

(a) You understand your access to and use of the System or its features or tools, exchanges and/or Contracts may be restricted if prohibited by local law of the jurisdiction from which you access the System

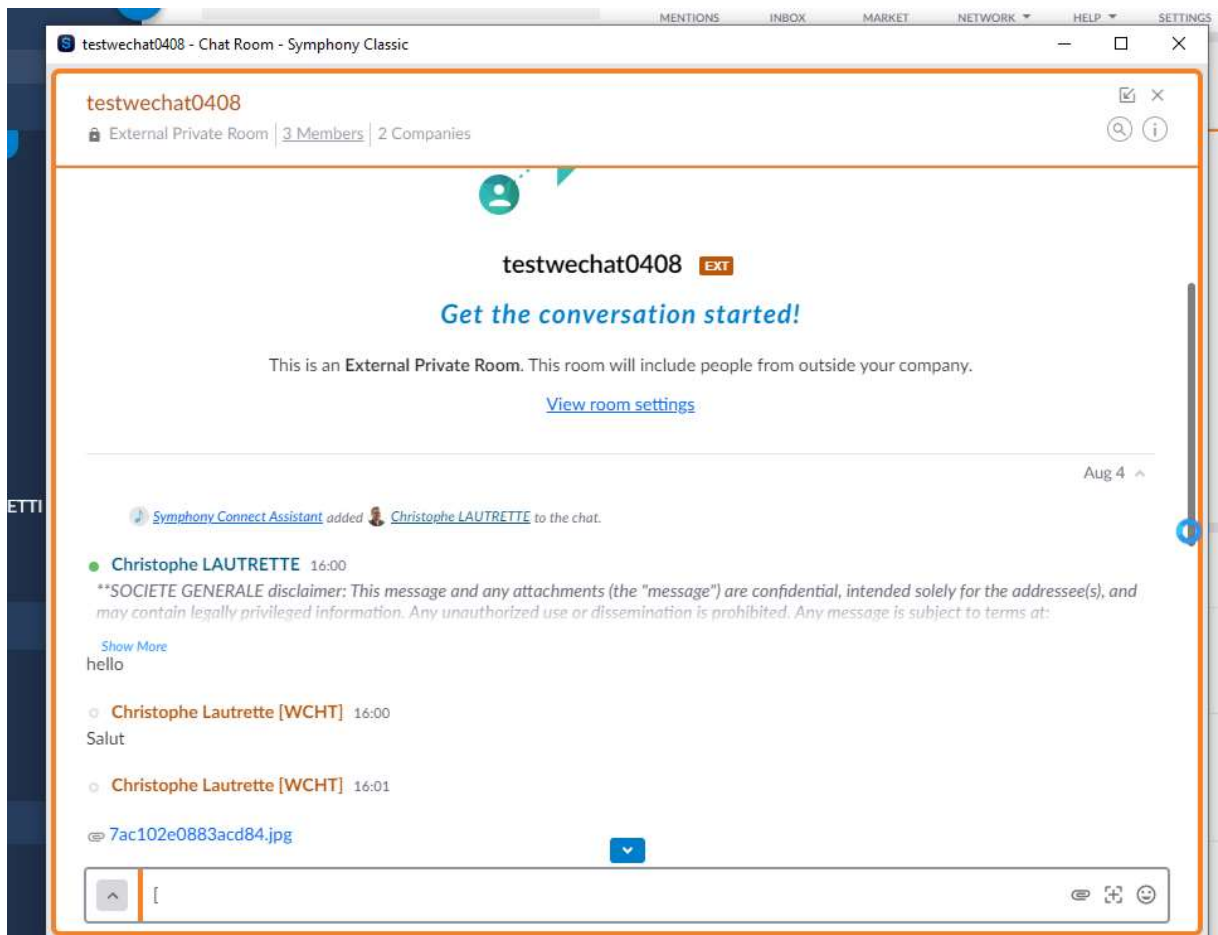
