You agree that you will not use the System or any ISV to send messages which are defamatory, fraudulent, contain personal data in contravention of any data protection regulation or legislation, or to facilitate any criminal transaction or act, contravene any law or any regulation, or do or omit to do any act or thing which might give rise to liability or a third-party claim against SGAS.

4. Responsibility for the Choice of System; Acknowledgment of Risks; Limitations on Liability.

- a) You accept responsibility for your selection and use of the System and any ISV and are solely responsible for providing and maintaining the computer(s), modem and the telephone line or Internet connectivity (as may be applicable) to connect to the System.
